NOTICE IS HEARBY GIVEN THAT A MEETING OF THE CLAY COUNTY CANVASSING BOARD TO BE HELD MAY 24, 2005 AT 6:00 P.M. AT THE SUPERVISOR OF ELECTIONS OFFICE, 1417-1 S. ORANGE AVENUE, GREEN COVE SPRINGS, FLORIDA TO OPEN ABSENTEE BALLOTS RECEIVED FOR THE LAKE ASBURY MUNICIPAL BENEFIT SERVICE DISTRICT (LAMSBD). THIS MEETING IS OPEN TO ALL POLITICAL PARTIES, CANDIDATES, PRESS AND THE GENERAL PUBLIC. ALL MEMBERS OF THE PUBLIC WHO WISH TO EXAMINE THESE ABSENTEE BALLOTS SHOULD BE PRESENT NO LATER THAN 5:00 PM ON MAY 24, 2005.

THE CLAY COUNTY CANVASSING BOARD WILL CONVENE ON MAY 24, 2005 AT 6:00 PM, AT THIS TIME A LOGIC AND ACCURACY TEST ON THE IV-C HIGH SPEED ABSENETT BALLOT COUNTER WILL BE CONDUCTED, FOLLOWED BY THE OPENING OF ALL ABSENTEE BALLOTS RECEIVED UP TO THIS TIME. AT 7:00 PM THE CLAY COUNTY CANVASSING BOARD WILL OPEN ANY ABSENTEE BALLOTS RECEIVED BY 7:00 PM. THE ABSENTEE BALLOTS WILL BE TABULATED THROUGH THE IV-C HIGH SPEED ABSNETEE BALLOT COUNTER AND THEN OBTAIN THE RESULTS FROM THE POLLING LOCATION IN CLAY COUNTY, WITH THE RESULTS BEING TABULATED AFTER 7:00 PM.

NOTE: IF A PERSON DECIDES TO APPEAL ANY DECISION MADE BY THE BOARD, AGENCY, OR COMMISSION WITH RESPECT TO ANY MATTER CONSIDERED AT SUCH MEETING OR HEARING, HE OR SHE WILL NEED A RECORD OF THE PROCEEDINGS, AND THAT, FOR SUCH PURPOSE, HE OR SHE MAY NEED TO ENSURE THAT A VERBATIM RECORD OF THE PROCEEDINGS IS MADE, WHICH RECORD INCLUDES THE TESTIMONY AND EVIDENCE UPON WHICH THE APPEAL IS TO BE BASED.
