

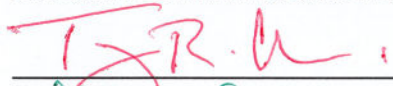
**CERTIFICATION

We, the undersigned County Court Judge, County Commissioner, and Supervisor of Elections, constituting the County Canvassing Board appointed to act during this election, do, by our signatures hereto, certify that to the best of our knowledge:

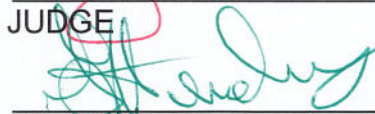
1. On November 16, 2018, commencing at approximately 9:00 a.m., the Supervisor of Elections had the electronic tabulating equipment, located in the Supervisor of Elections' Office, tested to ascertain that the equipment will correctly count the Mail, Early Vote and precinct ballot votes cast for all candidates.
2. The undersigned compared the test results with the predetermined totals for each candidate and, pursuant to the requirements established in Section 101.5612, Florida Statutes, observed the performance and results of all required tests and verified the correctness of the program and test ballots, as well as any replacement of said materials required by said tests, subject to said tests.
3. At the completion of this public test, the verified public test reports and test ballots are placed in the custody of the Supervisor of Elections in a security protected area.

All items, sealed as described above, were placed in the custody of the Supervisor of Elections.

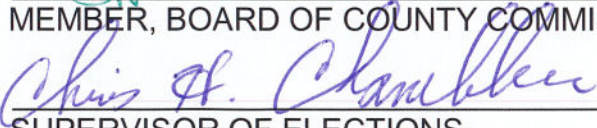

LOGIC AND ACCURACY TEST PLAN- MANUAL RECOUNT

Election: 2018 General- Manual Recount

Date: November 16, 2018

- All Public Tests will be performed at the Supervisor of Elections Office.
- The Supervisor of Elections provides for a video recording device to record the proceedings.
- The Canvassing Board will attest to approval of the test plan.
- The DS850 High Speed Counters shall be tested for the Public Test.
- A prepared deck of optical scan ballots produced by B.O.D/Vendor is read through the Model DS850 Absentee Ballot Counter.
- At least one (1) precinct for each ballot style will be counted to insure that each authorized race and ballot position is tested.
- The Public Test totals will be compared to a prepared listing of expected vote totals.
- The Public Tests are conducted with the identical hardware and software used at the actual election.

We, the undersigned County Court Judge, and County Commissioner, and Supervisor of Elections, constituting the County Canvassing Board appointed to act during this recount election, do, by our signatures hereto, certify that to the best of our knowledge the above listed procedures were used in the conduct of the Public Test for the manual recount of the General Election on November 6, 2018, in Clay County.
