ELECTION INSTRUCTIONS**PLEASE PRESERVE

Following are instructions for covering the general election Nov. 6 for The Associated Press and the member for whom you are correspondent. Please read them carefully and follow closely in making your reports so we may have the greatest speed and accuracy.

1. We will collect all returns by telephone and telephone only. Telephone the AP ELECTION BUREAU collect: MIAMI 754-4541. If when placing your calls the operator tells you there will be a delay because of busy circuits, tell her you are reporting election returns and the call must be rushed.

2. We want only cumulative returns. In other words, before placing your calls ADD UP THE TOTAL NUMBER OF PRECINCTS IN YOUR COUNTY THAT HAVE REPORTED AND THE TOTAL VOTE FOR EACH CANDIDATE FOR THAT NUMBER OF PRECINCTS and phone them in. Thus, your second report, for instance, MUST contain not only the returns available and reported on the first call, but those cumulative thereafter. For example, if on the first call Doakes has 100 votes in 10 precincts and if by the time of your second call 10 more precincts give him another 100 votes, your second report to us should credit Doakes with 200 votes in 20 precincts. This is elemental, of course, for those accustomed to election reporting.

3. In telephoning your returns, please be sure to state the county name and also tell the operator who is making the report. In reading votes cast, please do it this way: "Doakes four-eight-three" instead of "Doakes four hundred eighty three."

4. We do NOT WANT INCOMPLETE PRECINCTS. Wait for the complete totals of each precinct, so far as any one race is concerned, but not necessarily until all races are counted.

5. We want the results on election night of the MAJOR CANDIDATES WHO HAVE OPPOSITION IN STATEWIDE AND CONGRESSIONAL RACES, AND THE APPORTIONMENT AMENDMENT. The ballot forms attached show what candidates and what races we want reported by phone. When you phone in the complete vote in your county, please specify that your county is complete.

6. Make your first report when you have returns from one precinct on U. S. Senate or Congress. Call again when you have about five precincts, but at least once every 30 minutes until your county is complete--MORE FREQUENTLY if returns are rolling in rapidly. PLEASE STAY ON THE JOB UNTIL YOUR COUNTY IS COMPLETE.

7. If you have a State Senate or House race in your county, give us a report as soon as the outcome is definite. On your final call, please give results on amendments 2 through 9.
